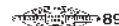

SUMMARY ANNUAL REPORT FOR THE BAC LOCAL UNION 15 WELFARE FUND

This is the summary annual report for the BAC LOCAL UNION 15 WELFARE FUND, EIN 23-7386028, Plan number 501 for the period April 1, 2008 to March 31, 2009. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$11,822,895 as of March 31, 2009, compared to \$10,797,863 as of April 1, 2008. During the year the plan experienced an increase or (decrease) in its net assets of \$1,025,032. This increase or (decrease) includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$8,908,192 including employer contributions of \$8,207,268, employee contributions of \$497,687, realized gains or (losses) of (\$76,757) from the sale of assets, and earnings from investments of \$175,759. Plan expenses were \$7,883,160. These expenses included \$609,420 in administrative expenses, \$7,273,740 in benefits paid to participants and beneficiaries, and \$0 in other expenses.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
