**Summary Annual Report for the
BAC LOCAL UNION 15 SUPPLEMENTAL PLAN**

This is the summary annual report for the BAC LOCAL UNION 15 SUPPLEMENTAL PLAN , EIN 43-6102453, Plan number 002 for the period April 1, 2009 to March 31, 2010. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Total plan expenses were \$2,623,722. These included benefit payments of \$2,358,467, administrative expenses of \$265,255, and \$0 in other expenses. A total of 1,205 persons were participants in or beneficiaries of the plan at the end of the plan year, although some may not have earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$38,498,997 as of March 31, 2010, compared to \$33,493,260 as of April 1, 2009. During the year the plan experienced an increase or (decrease) in its net assets of \$5,005,737. This increase or (decrease) includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income (loss) of \$7,629,459, including employer contributions of \$1,554,466, employee contributions of \$0, gains or (losses) of \$446,697 from the sale of assets, and net earnings from investments of \$5,614,878.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions or the report because these portions are furnished without charge.
