

SUMMARY ANNUAL REPORT

For BAC Local Union 15 Welfare Fund

This is a summary of the annual report of the BAC Local Union 15 Welfare Fund, EIN 23-7386028, Plan No. 501, for period April 1, 2023 through March 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BAC Local Union 15 Welfare Fund has committed itself to pay Health, Dental, Vision and Death claims incurred under the terms of the plan.

Insurance Information

The plan has a contract with Sierra Health And Life Insurance Company, Inc. to pay health claims incurred under the terms of the plan. The total premiums paid for the plan year ending March 31, 2024 were \$482,997.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$23,246,953 as of March 31, 2024, compared to \$21,650,227 as of April 1, 2023. During the plan year the plan experienced an increase in its net assets of \$1,596,726. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$11,826,741, including employer contributions of \$8,331,181, employee contributions of \$1,207,251, realized losses of (\$80,876) from the sale of assets, earnings from investments of \$2,114,002, and other income of \$255,183.

Plan expenses were \$10,230,015. These expenses included \$1,367,965 in administrative expenses, and \$8,862,050 in benefits paid to participants and beneficiaries.

If you request a copy of the full annual report from the plan

administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (BAC Local Union 15 Welfare Fund, Wilson McShane Corporation PO Box 909500, Kansas City, MO 64190-9500) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
